# **Standing Instructions 2025-26**

Field Trials will be held under Kennel Club Ltd. Rules and Field Trial Regulations (J Regs), copies of which can be obtained from the Secretary, The Kennel Club Ltd, 1-5 Clarges Street, London W1J 8AB, and those of the ISCGB.

**All Aged stake:** In accordance with Royal KC Rules & Regulations J3(d)(2) and J6(k)

Preference in the ballot will be given in the following order:

- 1. Members with Italian Spinoni
- 2. Members with other breeds
- 3. Non-members

**Novice stake:** In accordance with Royal KC Rules & Regulations J3(d)(3) and J6(j)(2)

**Open stake**: In accordance with Royal KC Rules & Regulations J6(i)(4) and J6(j)(1)

J4(c)(1)(ii) All dogs must be registered on the Royal KC Breed Register, or have a recorded Authority to Compete (ATC) number, to be eligible to compete in a FT.

J4(c)(1)(x) Should circumstances so dictate the ISCGB, in consultation with the Judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them will be reported to The Royal Kennel Club.

J4(c)(1)(xi) The ISCGB may reserve the right to refuse any entry, except that this shall not apply in terms of preference in the draw.

J4(c)(2) No modification may be made to the schedule after publication except by permission of the Kennel Club, followed by advertisement in appropriate journals if time permits before the closing of entries.

Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership.

**J6(e) Draw:** The draw will take place at the address of the FT Secretary at 9pm on the date given via Fosse Data. In the event of excessive entries, a ballot will be held. Results of the draw will be emailed to the address provided on the entry at the earliest possible convenience once the draw has been made. Owners/Handlers entering more than one dog, in the event of oversubscription, need to state preference in the draw as part of the entry process. Substitution of dogs is not allowed.

Entries & Entry fees: Entries will be via Fosse Data <a href="www.fossedata.co.uk">www.fossedata.co.uk</a> unless there are exceptional circumstances in which case please contact the FT secretary. Entries other than via Fosse Data, due to exceptional circumstances, together with a correct fee, must be received by the closing date specified, to the FT Secretary. Email entries will be accepted under exceptional circumstances, and bank transfers <a href="mailto:are">are</a> possible once a run is secured. <a href="mailto:Bank">Bank</a> Details: (Lloyds Account Number 03845457 Sort Code 30-96-17). Cheques/Postal orders made payable to ISCGB. Members are those that are fully paid up. <a href="Please check that your membership">Please check that your membership is up to date</a>. Non-members are those applying for membership, or whose membership has lapsed and whom the Committee has not yet considered.

**J6(f) Return of entry fees:** After an applicant has been successful in the draw for a place in a stake, or as a reserve has accepted an offer of a run, if the run is not been taken up, the applicant may become liable for the full entry fee, except where the applicant has qualified out of Novice Stakes or where the dog drawn to run has qualified for the Championship after the entries have closed, or on production of a veterinary certificate confirming that the dog entered for the stake is unfit to compete, or where the dog drawn to run is withdrawn more than 7 days prior to the stake. Un-presented cheques will be destroyed unless otherwise requested.

**Liability:** All persons attending these trials do so at their own risk. Neither the ISCGB nor the Hosts will accept liability for accident, injury or illness, damage or loss to any person, dogs or property, whatsoever.

No videography and/or photography will be allowed on the FT ground without the permission of the organising society.

J2 Welfare of Dogs: An exhibitor (or competitor) whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any field trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the trial.

**Spectators:** Spectators are only allowed with prior permission from the FT Secretary.

**Dogs in Cars on Hot Days:** Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog(s). If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.
